It is clarified that for the purpose of recruitment to the post of assistant professor, for seeking exemption from the screening test / award of weightage marks for those not eligible for exemption from screening test, candidates should have the Ph.D. degree in the relevant branch and the research publications (Category I/ Category II/ Category III) should be in the relevant research area of the discipline in which the candidate has applied.
