Clause R.1(B).24 (b) of Academic Programmes Ordinance & Regulations B.Tech. regarding semester withdrawal, which is reproduced below:-

However, such application shall be made under the advice of the Program Advisor, as early as possible and latest before the start of the End-Term Examination. Partial withdrawal from the semester shall not be allowed.”**
