The Anti Ragging Squad will conduct surprise checks on hostels, and other places vulnerable to incidents and having potential of, ragging and will be empowered to inspect such places. The Anti Ragging Squad will conduct an on the spot enquiry into any incident of ragging referred to it by the Vice Chancellor/Registrar or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be and the enquiry report along with recommendations will be submitted to the Anti Ragging Committee for action under clause (a) Rule 9.1 of the UGC Regulations on Curbing the Menace of ragging in higher educational Institutions, 2009. The Anti Ragging Squad will conduct the enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging and considering such other relevant information. The squads shall work under the overall guidance of Anti-Ragging Committee.
