The Directorate General of Health Service, Govt. of NCT of Delhi vide it's OM No. F. No. 1(12)/H&F/DGHS/4436-4686 has conveyed the approval of Hon'bie Lt. Governor, Delhi for mandatory "Annual Health Check-up Scheme for all serving Government employees of Government of NCT of Delbi aged 40 years and above "(Annexure-I), Further vide OM dated 27.11.2019 (Annexure-II), the modalities for carrying out Annual Medicai Health Check up is enumerated by Services Department, GNCTD.

Accordingly, all the officers/officials/ex-cadre/teaching staf/ of DITE including Universities which are funding by Govt. of NCT of Delhi i.e. DIPSRU, NSUT, AIACT&R, CBPGEC and DSEU on attaining the age of 40 years shall be required to get the prescribed Annual Medical Examination, in the month in which his/her birth date falls for subsequent years. The current year 2024-2025 is the year of introduction of the scheme.

The Government employee will seek 'permission letter' from "Head of Office" of the Department from where the employee is drawing salary for getting the mandatory Medical check-up from any of the empanelled Hospitals as prescribed by DGHS vide their OM dated 05.11.2019 @ Rs. 2000/- for Male and Rs. 2200/- for Female to be reimbursed to the apployee concerned on production of original voucher.

The APAR without the summary of health report shall be treated as incomplete and may be taken as "Adverse" '
